Alastair says the perfect holiday includes a seamless booking and checkout experience. "Often we're talking about quite a large sum of money. It's important for our customers to be able to transact in their native currency."

There are plenty of challenges that come with taking bookings from more than 50 countries. "Understanding and adapting to different cultural norms and behaviours in various countries can be challenging. Each market has its own preferences, which may require adjustments in strategies, contracts, and communication styles."

Having a payments platform that helps remove many of the complications in cross-border finance—taking payments in native currencies is a game-changer. "I remember inquiring with our bank about setting up multiple currency accounts so that we could receive payments in different currencies, and it was going to be quite expensive to do that. So with PayPal holding all of these different currencies for us, we saved a lot of money."

To further improve their customers' user experience, the team reduced their checkout process from three steps to one with an embedded payment gateway plugin. Alastair says the improvement in conversion was instant.

Sara adds, "And that's without increasing our traffic to our website."
