

PayPal - \$20 back on Pay in 4 Transactions **Promotion Terms and Conditions**

“Eligible Participant”: Only open to Australian residents who: (1) are eighteen (18) years of age and older; (2) are the holders of an Australian PayPal Personal account in good standing (**“Valid Account”**); (3) have been invited to participate in this Offer by PayPal through email or through the PayPal app (4) have first successfully completed their Offer Enrolment, and (5) have then completed an Eligible PayPal Pay in 4 transaction within the Qualification Period.

“Offer Enrolment”: Eligible Participants must first successfully enrol in the Offer between 3 March 2026 at 12:01:00AM Australian Eastern Daylight Time (**“AEDT”**) and 11:59:59 p.m. AEDT on 6 March 2026, by completing the steps on the [Enrolment page](#) while logged into their PayPal account.

“Qualification Period”: Starts on 3 March 2026 at 12:01:00AM Australian Eastern Daylight Time (**“AEDT”**) and ends at 11:59:59 PM AEDT on 6 March 2026 or when all 25,000 Rewards have been rewarded, whichever is earlier.

“Eligible Pay in 4 Transaction”: A PayPal Pay in 4 transaction, completed by a successfully enrolled consumer of AUD \$200 or over within the Qualification Period, that has not been reversed. Pay in 4 is subject to eligibility and suitability assessment and only successful Pay in 4 transactions will qualify.

“Reward”: \$20 AUD added to, and for use via, the Valid Account. The Reward is subject to restrictions and exclusions on use, as outlined in these Terms and Conditions.

Eligible Purchases exclude: (1) send/request money transactions (including those marked as a “Goods and Services” payments), (2) charitable donations, (3) PayPal transaction fees, (4) Withdrawal to bank, or (5) transactions made in any other currency that are not AUD (Australian dollars).

2. Once successfully Enrolled, proceed to make a new "Eligible PayPal Pay in 4 Transaction" of AUD \$200 or over within the Qualification Period.
3. The Reward will be auto delivered into Eligible Participant's Valid Account PayPal account under between 15 to 90 business days from the date the PayPal Pay in 4 transaction was initiated, as long as the Eligible Transaction has not been reversed, cancelled or refunded.
4. Regardless of marketing preference, by enrolling in this offer you agree that you will be notified via an automated system email from PayPal that your Reward is in your wallet and is ready for use, and reminded on day 5 and day 15 prior to expiry date if the Reward has not been redeemed.
5. Once received in a Valid Account's PayPal account, the Reward will be automatically applied to the first "Eligible Purchase" made using the Valid Account during the Redemption Period. The Reward will be automatically applied to a PayPal pay in full transaction or Pay in 4 instalment, whichever occurs first.
6. Use of the Reward will be reflected on your PayPal receipt and/or in the transaction details of your Valid Account.

Further Terms: A Reward must be redeemed during the Redemption Period and no later than six weeks from the date the Eligible Participant receives the Reward in their Valid Account.
